Therefore, we do everything we can to guarantee that data is protected and that we operate in compliance with the General Data Protection Regulation (GDPR) when processing your personal data. Atmooz always takes responsibility for the processing of personal data gathered through our website, <u>www.atmooz.com</u>.

Personal Data

We define processing personal data as: a single instance or series of instances of processing personal data or a pool of personal data, whether or not conducted using automated procedures, such as collecting, recording, structuring, storing, altering or adjusting, querying, consulting, using, providing through a referral, disseminating or otherwise making available, aligning or combining, securing, deleting or destroying data.

In accordance with current regulations, we consider personal data to be: all information about an identified or unidentifiable individual ("the relevant party"); identifiable is considered to mean an individual who can be identified directly or indirectly, particularly using an identifier or one more elements that describe the individual's physical, genetic, psychological, economic, cultural or social identity.

Examples of personal data are name, address or e-mail address, but this also includes your IP address.

You alone are responsible for the information you provide to us. We trust the veracity of this information.

When you sign up for your newsletter, take part in a contest or place an online order, information is collected which may contain personal data. This data is actively collected by asking you certain questions and giving you the opportunity to contact us directly. Providing certain data can be advantageous, as it allows you to enjoy certain promotions or to take part in certain activities. In order to make your visit to our website as appealing as possible, we aim to personalize our site to the greatest extent possible and to continuously improve it. When you navigate our site, it is possible for certain data, such as IP addresses, cookies and surfing data, to be collected passively by means of Internet technologies, without you actively providing this information.

Why do we process your personal data?

By using our online services, you grant us permission to use the data provided in order to improve our online services, to adapt our website to your preferences, to provide information (upon your request), to use the data in our marketing and research activities, and to sell and deliver products, as well as for other purposes, as described in this privacy policy.

To whom do we release your personal data?

We can pass your personal data on to third parties who have been asked to deliver certain products or services (e.g. technical and logistical services or financial transactions), on the condition

that the third party have agreed to abide by the restrictions set forth in this privacy policy. Your personal data will not be released to third parties who are not part of our production process.

In addition, we can make any and all use of all non-personal data gathered via this online service. Your personal data will only be used within the legal framework, based on your permission.

Credit card payments will only be saved via Mollie, an oft-used, PCI-approved European supplier of payment services. Our servers contain personal data, but this will never include any information pertaining to payment methods or bank details.

Atmooz will endeavor to only ever process personal data within the European Economic Area.

How long do we store your personal data?

Your personal data is only processed as long as it is necessary for the purposes described in the Privacy Statement, or until you revoke your permission to process the data. In that case, we will take the necessary steps to cease processing your personal data as soon as possible.

What rights do you, as a relevant party, have?

As a relevant party in this privacy policy, you have a right to access all of the personal data about you that Atmooz processes.

As a relevant party, you have the right to request the rectification of personal data that is incorrect or imprecise.

When your personal data is being processed based on your permission, it is still possible for you to revoke this permission. You can do so by contacting us at <u>hello@atmooz.com</u>.

As a relevant party, you have the right to request that your personal data be deleted, if they are no longer necessary in light of the purposes set forth in this Privacy Statement, or if you revoke permission to process the data. This right cannot be exercised if other legal obligations require Atmooz to process this personal data further.
